PURPOSE OF THIS ASSESSMENT TOOL

This tool is designed to cover selected aspects of a country's alternative care system that might best indicate, through assessment, the quality of the care being delivered.

This assessment tool focuses on the range of measures to prevent family separation, the various living arrangements for children in alternative care and the administrative arrangements managing those services. It will also explore the national legal and policy framework which governs the delivery of all of these services. The tool is based on the articles of the UNCRC, and the 2009 UN Guidelines for the Alternative Care of Children

There are three types of questions to each area covered by this assessment tool:

1. Data of children
These questions look at the scale of problems and the attitude of providers
2. Sources of data and additional comments (**green box**)
This helps secure the credibility of the data and allows the researcher to comment on the data, the source and their personal thoughts. It also allows for comments on the lack of data.
3. Legal compliance (**blue box**)
These questions look at the real children's human rights issues behind the data

The availability and content of information on children in alternative care naturally determine to a large degree the extent to which policies and responses are likely to be appropriate and adequate. Guideline 69 specifies that: "coordinated **policies** regarding formal and informal care for all children who are without parental care [...] should be based on **sound information and statistical data.**"

In many countries, much of the required or desirable data may not exist at national level, and this in itself is of course telling and should be noted. To the extent that, for the purposes of this assessment, data are gathered from scratch, this should therefore be clearly indicated.

3. PREVENTATIVE SERVICES

The 2009 Guidelines place considerable emphasis on the need to assist families to remain together, preventing the need for placing children in the alternative care system. Such assistance may take a variety of forms, and may concern general accessibility of services or targeted interventions.

Does national policy...

..Ensure the systematic collection of relevant data on the causal factors of family vulnerability and ensure that relevant data informs service delivery in support of families?

... Provide guidance on parenting and quality parental care?

..Foresee appropriate interventions to support and strengthen families in order to prevent separation and ensure that these interventions are consequently resourced, targeted, and implemented?

..Guarantee that family-oriented policies are in place and implemented to strengthen family environments without discrimination based on, for example, marital status, birth status, poverty or ethnicity?

..Recognise and promote the common responsibilities of mothers and fathers and ensure that they are equally empowered with the relevant attitudes, skills, capacities, and tools to provide a caring environment for the child?

..Ensure coordinated service provision and a range of relevant services to ensure tailored and appropriate responses to families facing difficulties?

...preview qualification and training schemes for staff and services working with families

...prescribe responsibilities for the coordination of family services clearly assigned

...ensure that there are measures in place to evaluate the use of these services and identify and remove obstacles and barriers related to access and availability?

..promote and support the development and implementation of a range of appropriate family support services as preventative measures to ensure children can be cared for within their families?

..provide for parenting education, and other relevant supports to parents in particular, for example, adolescent parents, to prevent child abandonment?

4. INFORMAL CARE

In the majority of countries, most children who are not living with their parents, for whatever reason, are looked after by other persons (family members or others) on an informal basis. State services are not directly involved, by definition, in such informal arrangements. However, the 2009 Guidelines set out a number of principles that should be followed by the State in order to support desirable arrangements of this kind and to ensure as far as possible the continued protection and well-being of children in such informal care settings.

This section therefore seeks to gain basic insight into the realities of informal care provision.

5. MOTIVES FOR PLACEMENT

Guidelines references: 14, 22, 29, 47 etc.

It is important that care providers know and record the circumstances of each child's admission into alternative care, as this should clearly be a major consideration in care planning. Equally, the State should be aware of the reasons for which children come to be in care settings, and related trends, in order to draw up and refine child protection policies. Each child's family situation will differ, as will the weight of different factors that might lead to an alternative care placement. It would not be possible in the context of the present assessment exercise to analyse the vast array of possible specific causes. However, an important indicator is whether or not the placement results from a decision of the competent authorities or the parents, where the placement is made, and whether that decision concerns a placement that will in principle be temporary or permanent. This section deals with those issues.

..dictate that poverty alone is never the primary justification for children being removed from their family and placed in alternative care?

..ensure that comprehensive criteria are used to assess the capacity of the family to care for the child when a risk to the child in that family has been identified?

..guarantee that parents and children fully participate in the decision-making process and are kept informed of their rights, particularly their right to appeal against a decision to remove a child?

..ensure that assessment processes are informed by multi-disciplinary perspectives on, for example, education, health, and other relevant areas of concern?

..require assessment processes to give all due consideration to identifying necessary supports for the family and make referrals to relevant services as an alternative to separation?

..support and encourage the training of professional groups, such as teachers and doctors, in identifying children at-risk and oblige them to make referrals to relevant services and responsible authorities?

..ensure vulnerable parents seeking to relinquish their children have access to counselling and financial or material support to care for children to prevent child abandonment?

..make provision for procedures which support those children who have been abandoned in gaining confidential access to relevant and appropriate information on their background?

6. ADMISSION PROCESS AND PLACEMENT/REVIEW PROCEDURES

Guidelines references: 44, 45, 74, 125 etc.

A fundamental element of “quality care” is making sure that alternative care is used only when necessary and is then carried out in the most appropriate setting for the child. This implies a series of assessments from the moment that alternative care is envisaged for the child (gate keeping) and subsequently throughout the placement(s) (care planning and review). Assessment at the gate keeping stage should ensure that all possibilities other than a care placement (remaining with family, kinship care, etc.) have been examined and discounted. The usefulness and impact of such an assessment exercise will most often depend considerably on the existence of family support services that can be mobilised to make a non-placement solution viable. Gate keeping should also determine which care setting is initially the most suitable for the child in question where placement appears to be the only or best option.

Once a placement is made, an initial care plan should be drawn up, taking account of the needs and circumstances of the child, directed towards that child's eventual return to the family where possible, or another stable and secure environment. Thereafter, regular reviews of the plan are needed to establish whether or not the child continues to need alternative care and, if so, whether or not the current care setting still responds most adequately to his/her needs and situation. Such reviews should therefore serve as the basis for decisions to move from one care setting to another or to end alternative care completely for the child in question.

This section looks at the degree to which this series of assessments is implemented.

Does the law require and set out an admission process (gate keeping) for all children going into care?

..oblige care providers to ensure the implementation of rigorous, multi-disciplinary approaches to decision-making that includes the informed participation of children and their families?

..oblige care providers to ensure that comprehensive records are kept from the outset so that, for example, the initial decision-making process provides a solid foundation for future care planning and regular reviews?

..dictate that periodic reviews of the care placement give all due consideration to the general conditions of care experienced by the child, the continued necessity of the placement, and take account of the views of the child?

..oblige care providers to ensure individualised care solutions that promote stability and permanence in planning care, through reunification with the family, or the continued provision of alternative care?

The first vital step to ensure quality care is of course to know where care is being provided and to monitor the way in which it is provided. Thus, registration, assessment, approval and inspection of private residential care facilities are necessary. While it can be presumed that all public facilities are known to, and authorised by, the competent authorities, they of course still need to be inspected regularly. 10. FINANCING ALTERNATIVE CARE

Guidelines reference: 108 etc.

The Guidelines outline a regulatory framework that emphasises State responsibility for the authorisation, monitoring and accountability of care providers, care facilities and individual carers.

While the amount of financing made available to the alternative care system and each of its constituent parts will likely affect the conditions of care, the way the system is funded can have profound implications for the manner in which it is used. In particular, the source and basis of funding can greatly influence the number of children in care and the kind of setting in which they are placed.

This section therefore seeks to shed light on the extent to which the different parts of the care system are financed by the State – at central, regional or local levels – or through private sources, within the country or abroad, and the criteria adopted for the provision of funds.
